### **1. PRESENTATION**

Among its goals, Fundación WWB Colombia's strategic plan is intended to "promote the creation, dissemination and appropriation of knowledge to identify the inequality gaps affecting women and help to reduce these" by applying various mechanisms, one of which is the Fundación WWB Colombia Research Fund<sup>1</sup>. Under this principle, Fundación WWB Colombia presents its fourth call for research funding (call IV-2020)<sup>2</sup>, offering grants of COP \$726,000,000 to strengthen our commitment to build knowledge for social change that promotes greater inclusion in democratic societies.

This fourth version of the call is intended to: "promote research that proposes the study of the dynamics, tensions, imaginaries, relations, conflicts, challenges, and opportunities for entrepreneurship led by or with the participation of women in the departments of Chocó, Valle del Cauca, Cauca and/or Nariño - Colombia."

The projects submitted to the call must consider the current COVID-19 emergency and how it may affect fieldwork in the communities. Applicants are encouraged to include alternatives in their proposals that involve online and/or strict biosecurity measures to ensure the health and integrity of everyone involved in the projects, as well as working from existing databases to reduce the number of field trips. In this regard, Fundación WWB provides the following materials to support the adjustment of proposals submitted to the new call, and to contribute to the closing of new gaps that the pandemic has accentuated for women:

- 1. Newsletters with information related to the pandemic and gender violence, necessity entrepreneurship, financial inclusion, ICTs and digital appropriation, possibilities of reviving entrepreneurship, and business and mental health. The documents are available on the Foundation's website<sup>3</sup>.
- During August 2020, conversations will be held on several platforms<sup>4</sup> focusing on virtual fieldwork and other forms of remote fieldwork (reflections and experiences) in order to start implementing ICT tools in their development.

Note: Proposals for on-site fieldwork will not be accepted under this call unless they are carried out by EU researchers living in the local territory where the research is being carried out and the methodology explains in detail which biosecurity measures will be taken.

## On collaborative and participatory research

The participatory action research (PAR) is a methodology and perspective of research and action that promotes the exercise of research as a tool for social change, through the active participation of people involved in the process of knowledge creation, from project design, data collection, to the actions resulting from the process (Fals-Borda, 2015: 320). The end goal of PAR is for members of socially and economically disadvantaged groups to participate actively in the management of their organizations and communities, and to be able to influence processes that directly or indirectly affect their quality of life and exercise of self-determination.

According to Rodrigo Contreras (2002: 11), PAR is a tool through which to raise awareness and disseminate knowledge. It allows the operationalization of research processes to change reality. The author proposes the following objectives for the PAR:

- Promote collective knowledge production, where the monopoly of knowledge and information, historically held by academics when doing research, is broken, and for these to be the property of both the academic-researcher and the research communities.
- Encourage collective data analysis.
- Promote the critical analysis of the information, aiming to identify the causes of the phenomena, their manifestations, and possible routes of action to be taken.
- Identify the relationship between individual problems and collective problems, as well as between functional and structural problems, as a fundamental element in the search for collective solutions to the problems experienced.

The IDB suggests numerous benefits of promoting community participation in research processes (1997). First, it reduces the cost of obtaining data, and maximizes its relevance to the problems identified by communities. Second, it can be useful in managing community conflicts by creating a common basis for negotiation and action, thus reducing the cost of monitoring the implementation of actions arising from the research process. Thirdly, it



promotes stakeholder commitment to social change because people identify a common purpose by jointly generating and analyzing information they have collected, setting priorities and developing strategies. When people have a greater sense of ownership for the projects that are developed in their context, they are more willing to overcome obstacles. Fourth, participation can strengthen local institutions' capacity for self-management, when they are involved in the process. Finally, the groups involved can follow up on the projects that are being executed in their territories and determine whether they are being implemented in an equitable manner, and demanding corrective actions where necessary.

Participatory and collaborative research projects submitted to this call are expected to be based on a joint definition of the research goals, and specifically on the scope of the relationship between academic researchers and community organizations/collectives/researchers. In this sense, and based on the postulates of PAR (IDB, 1997), we suggest considering the following:

- 1. Identify joint goals for the research process.
- 2. Establish clear agreements regarding the scope, responsibilities, rights, consensusbuilding and conflict resolution mechanisms, resource management (of different types), expected results and outcomes, among others.
- 3. Avoid simplifying the groups in an authorized representation or voice.
- 4. Recognize the power relationships, divisions, different interests, and diverse voices within the associated collectives, by both the academic researcher and the community organizations/collectives/researchers.
- 5. Periodically review (in operational terms at least once before submitting an interim report) the validity of the agreements reached and redirect efforts to new agreed objectives/relationships/responsibilities.
- 6. At the end of the process, assess the results obtained and the lessons learned, determining, as applicable to the case, PAR requirements in a subsequent cycle.

## **On applied research**

According to the Frascati manual, "applied research is fundamentally directed toward a specific practical goal or purpose. It is undertaken to determine the possible uses of the results of basic research, or to determine new methods or ways to achieve specific predetermined goals. This type of research implies the consideration of all existing knowledge and its deepening, in an



attempt to solve specific problems" (OECD, 2015: p.54).

Thus, this type of research is aimed at building or developing new knowledge in order to solve a specific need identified, which in the case of this call is related to the communities and territories of the Colombian Pacific region. To achieve this goal, all existing and available knowledge must be considered in order to provide a solution to the identified problem situation, as well as the participation and fully informed consent of the community with which the work will be conducted.

## 2. RESEARCH FIELD DEFINITION

"Contexts and opportunities for women's entrepreneurship in rural areas."

## 3. JUSTIFICATION

This call will finance research, social innovation, and technological development projects focusing on rural entrepreneurship in relation to, in general terms, women's empowerment according to indicators suggested by a number of studies on the subject<sup>5</sup>, as well as by reports published by international organizations, e.g., UNFPA<sup>6</sup>.

Mestizo, indigenous, Afro-descendant and Raizal rural women live in a variety of economic, social, cultural, political and agro-ecological circumstances. However, two elements common to these contexts in Colombia are the influence of a sense of community, on the one hand, and, on the other, the close relationship between the livelihoods and ways of life of these communities and the rural environment. Although it is neither possible nor appropriate to give a definition of the category of "rural woman," we can consider certain characteristics that may be common to many women who live and work in rural areas in the Pacífico region.

Women who live and work in rural areas generally contribute substantially to family income, family reproduction, and territorial and community development. Many are entrepreneurs, others work as wage earners, and some do not receive a salary or income commensurate with the effort they make. They often lack access to the opportunities that would allow them to develop their own enterprises due to the particular nature of productive chains, the local markets, the structure (at different levels) of wealth distribution, and the relevant symbolic universes for the specificities of the gender relations that prevail in such contexts, among other obstacles.

Rural communities could produce and trade multiple products and services, if only the mechanisms for enterprise development were more easily available, i.e. transport routes, development programs, access to validation procedures, etc. This lack of access to opportunities for the development of entrepreneurial, financial, and digital skills are among some of the barriers that prevent enterprise creation in in these population sectors.

One of the goals of Fundación WWB Colombia is to close the gaps in relation to women's inequality. This renders essential the production of knowledge about and for the characteristics, needs, skills, organizational processes, and challenges faced by women in rural Colombia, specifically in Pacifico region, when considering entrepreneurship processes as a mechanism of empowerment.

#### 4. GOAL

This document presents the specific characteristics of the "**support for fieldwork: collaborative and participatory research and applied research**" category of the fourth Fundación WWB Colombia call for proposals, including application guidelines.

## 5. TARGET POPULATION

Master's or doctoral students of any nationality who require funding for the fieldwork for their undergraduate theses; research, technological development and innovation groups attached to national institutions recognized by Colciencias; and research groups belonging to foreign institutions with respective accreditation from relevant organizations in the host country, and that demonstrate academic excellence, regardless of the nationality of its members.

This call supports and promotes the following types of research projects:

- Master's degree projects: collaborative/participatory research.
- Master's degree projects: applied research.



- PhD thesis projects: collaborative/participatory research.
- PhD thesis projects: applied research.
- Research projects by Colombian or foreign research groups: collaborative/participatory research.



• Research projects by Colombian or foreign research groups: applied research.

## 6. PHASES OF THE CALL<sup>7</sup>

**a. Application period***:* runs from July 27 - August 31, 2020. During this period, applicants must fill in the proposal form and upload it to the platform together with the documentation required for this phase (see checklist on page 31).

**b.** Concession period: corresponds to the intermediate stage between the publication of results and the validation of a project. It begins on October 1 (date of the publication of results for master's and PhD students) and October 9 (date of the publication of results for research groups), and ends on November 5, 2020. During this period, the applicants must present the institutional guarantees for their proposal. In some cases, academic institutions endorsing these research proposals may take longer than expected to issue these documents. It is therefore the responsibility of the applicants to request them in time, so that they are processed by the appropriate institutional units and submitted to the Fund within the established deadlines. If these requirements are not met, financing cannot be validated and the funds will be lost.

**c.** Validation period: corresponds to the contract for service provision or co-financing agreement coming into force. It begins on November 10, when the Fund calls on applicants to provide the documents required to join the Foundation (as appropriate for natural or legal persons) and ends with the delivery of the signed contract and other documents required on December 10.

c. Execution period: the time established to develop the research project, which must not exceed
12 months.

d. Closure period: corresponding to the submission and approval of the deliverables for project closure and the fulfillment of the other obligations established for contract settlement. The deliverables must be sent to Fundación WWB Colombia no later than two calendar months after the end of the execution period. Requests for additional documents, rectifications, and approval of deliverables will be made during the two calendar months following the date of the beneficiary's submission of the documents. The contract will be settled once all the deliverables

and requirements agreed at the beginning of the project have been met.

## 7. APPLICATION REQUIREMENTS

## Master's degree thesis

- 1. Hold an undergraduate degree (regardless of nationality) and be enrolled on a master's program in a Colombian or foreign educational institution.
- 2. Have a research project -with fieldwork conducted in Chocó, Valledel Cauca, Cauca and/or Nariño- approved by the evaluation committee of the respective academic program. The work proposal must be presented in Spanish. Those who have their original proposal in English or another language may attach it as an additional document, without this replacing the requirement to submit the proposal in Spanish.
- 3. Have the support of a thesis supervisor. The application must be completed jointly by the candidate and his/her thesis supervisor. To this end, the supervisor will complete and sign the "supervisor's endorsement" form.
- 4. Present two proposals for dissemination activities<sup>8</sup>. The first is to be presented after the submission of the project's progress report (midway through the execution period), among the Foundation's associates (users, collaborators, and interested parties). The second is to be presented at the end of the execution period to the associates of the university to which the researcher is linked. The purpose of these activities is to bring the Foundation's user population and the academic community closer to the research processes supported by the organization. At least one person from the community or social organization involved in the research project must participate in these meetings (online) and act as their representative.

## Research projects presented by Colombian or foreign research groups

- 2. The research group that endorses the proposal<sup>12</sup> must be recognized by Colciencias or endorsed by the foreign academic institution to which it belongs.
- 3. The project-executing entity must provide a counterpart of 20% of the total cost of the project, in cash or in kind, duly specified in the budget form.
- 4. Present two proposals for dissemination activities<sup>13</sup>, The first is to be presented after the submission of the project's progress report (midway through the execution period), among the Foundation's associates (users, collaborators, and interested parties). The second is to be presented at the end of the execution period to the associates of the university to which the researcher is linked. The purpose of these activities is to bring the Foundation's user population and the academic community closer to the research processes supported by the organization. At least one person from the community or social organization involved in the research project must participate in these meetings (online) and act as their representative.

### 8. ELIGIBILITY REQUIREMENTS

Once the results of the call have been published on October 1, 2020, October 1 (date of the publication of results for master's and PhD students) and October 9 (date of the publication of results for research groups), selected applicants will have to submit the required documentation to begin the concession period. The following are the main considerations that applicants must consider at this stage of the call:

- 1. The proposal must correspond to one of the three participation modalities.
- 2. The proposal must have institutional support (endorsement of the legal representative) to process all the documentation that will be requested in this concession period and later, in the validation phase.
- 3. In the months prior to the publication of the results, the applicants must begin to manage the ethical and institutional guarantees listed below in order to comply with their timely delivery.

## Documents required for master's and PhD thesis projects

- 1. Research proposal adjusted as required by the Academic Assessment Committee and signed by the legal representative of the institution in which the applicant is enrolled.
- 2. Ethics Committee endorsement certificate issued by the Ethics Committee or its equivalent at the institution endorsing the project.
- 3. General budget form (PDF) signed by the supervisor and the applicant.
- 4. Grades certificate (MA students only). This document must include the cumulative grade point average to date.
- 5. Certificate of study issued by the educational institution where the applicant is enrolled as a doctoral or master's student.
- 6. For research group projects of foreign universities: in the case of projects that are not endorsed by a Colombian institution (academic or social), applicants must attach a letter of presentation of academic or social instance at national (Colombia), regional (Valle del Cauca, Cauca, Chocó or



Nariño), or local level, that accredits the relationship with the researcher and that propitiates a local anchorage of the knowledge produced.

- 7. Colombian bank account certificate in the name of the applicant.
- 8. For doctoral students who present a proposal for participatory and/or collaborative research, a letter signed by the legal representative or leader of the community organization with which they are collaborating must be attached, specifying the following:
  - Contact information (name, position, telephone and e-mail)
  - Purpose and scope of collaboration
  - Commitments made by the parties for the execution of the work proposal
  - Time of relationship between the parties in previous projects and activities

## Documents required for Colombian and foreign research groups

- 1. Research proposal adjusted as required by the Academic Assessment Committee and signed by the legal representative of the institution in which the research group is enrolled.
- 2. Ethics Committee endorsement certificate issued by the Ethics Committee or its equivalent at the institution endorsing the project. Institutional endorsement form signed by the legal representative of the academic institution<sup>15</sup>. This form includes a section that mentions the value in pesos of the counterpart provided by the institution; this must coincide with the amount specified in the Budget form in Excel.
- 3. General budget form (PDF) signed by the leader of the research team and the legal representative of the institution endorsing the proposal (available on the platform).
- 4. For participatory and/or collaborative research projects, attach a letter signed by the legal representative or leader of the community organization with which you are collaborating, specifying the following:

For research group projects presented by foreign universities: in the case of projects that are not endorsed by a Colombian institution (academic or social), applicants must attach a letter of presentation of academic or social instance at national (Colombia), regional (Chocó, Valle del Cauca, Cauca, or Nariño), or local level, that accredits the relationship with the researcher and that propitiates a local anchorage of the knowledge produced.

#### 9. DURATION AND FUNDING

In all cases, the fieldwork periods for proposals submitted for funding should not exceed twelve (12) months.

Fundación WWB Colombia has seven hundred and twenty-six million pesos (COP\$726,000,000) available to fund the research proposals selected in this fourth version of the call.

**Master's degree thesis:** Up to four (4) master's degree projects will be funded: two (2) in the participatory and/or collaborative research category and two (2) in the applied research category. Up to twenty-three million pesos (COP \$23,000,000) will be granted per collaborative and/or participatory research project and up to thirty-four million pesos (COP \$34,000,000) per applied research project.

**PhD thesis:** Up to two (2) doctoral degree thesis projects will be funded. Up to forty-five million pesos (COP \$45,000,000) will be granted per collaborative and/or participatory research project and up to sixty-seven million pesos (COP\$67,000,000) per applied research project.

**Research projects presented by Colombian or foreign research groups:** Up to four (4) research projects presented by national and/or foreign groups will be funded: two (2) in the collaborative and/or participative category and two (2) in the applied research category. The amount funded per collaborative and/or participatory research project is up to one hundred million pesos (COP\$100,000,000) and up to one hundred and fifty million pesos (COP\$150,000,000) per applied research project. In both cases, the value financed will be equivalent to up to 80% of the total amount of the project. The executing agency must provide a counterpart of 20% of the total cost of the project, in cash or in kind, duly specified in the budget form.

The Academic Committee in charge of making the final selection may modify the number of projects financed by category, depending on the quality of the proposals submitted.

#### **11. BUDGET**

For work proposals submitted by **research groups**, the executing entity must provide a counterpart equivalent to 20% of the total cost of the work proposal, in cash or in kind. This percentage must be endorsed by the institution's legal representative, through the "institutional

The resources allocated to proposals for **master's degree projects or doctoral theses** may not be disbursed unless the selected candidates have submitted all the documents required in the application and concession periods (certificates, ethical and institutional guarantees).

The resources available for this call should be budgeted bearing in mind that there will be two disbursements: the first when validating the research grant, and the second halfway through the execution period. Resources may be considered to cover expenses directly related to the fieldwork of the submitted proposal. The definition and scope of each item can be found in the "Items to be financed" section available in the **call's regulations document**. The proposals submitted to the call will strictly follow the guidelines of the Implementation Regulation document regarding the scope of each item. These include the following:

- Registration
- Supervision expenses (including field visits)
- Expenditure incurred prior to the commencement of the research grant contract

### **13. ASSESSMENT PROCEDURE**

The proposals will first pass through a filter established by the Fundación WWB Colombia Research Board in order to discard proposals that do not comply with all the requirements established in the call. The selected proposals will then be sent for external evaluation

Proposals sent by master's and doctoral students will be assessed by external evaluators. The top ten (10) master's and top eight (8) doctoral scores will be validated by the senior team of Fundación WWB Colombia Research Board.

The twelve (12) proposals from research groups that receive the highest score from the external evaluators (more than 60 out of 100 points) will be assessed by Fundación WWB Colombia's Academic Committee<sup>20.</sup>

Fundación WWB Colombia's academic committee, made up the President, two representatives of the Board of Directors, an external evaluator, and WWB's Research Board, will select the winning proposals based on recommendations made by the evaluators.

Two research grants will be guaranteed in the participatory and/or collaborative research category for Colombian students studying for a master's or doctorate degree at the Latin American Faculty of Social Sciences -FLACSO Ecuador.

The categories may be declared void if the proposals do not meet the expected standards.

#### **14. RESEARCH FIELD**

The following is a list of possible research areas in which the funded research projects in the field of "contexts and opportunities for women's entrepreneurship in rural areas"<sup>21</sup> could be framed. This list is not exhaustive and serves as a reference only<sup>22</sup>:

#### COVID-19, actions for prevention and recovery

## **16.** AUTHORISATION TO PROCESS PERSONAL DATA<sup>23</sup>

For all legal purposes, the presentation, inscription or registration of the work proposal, unequivocally and exclusively for the purposes of this call, necessarily implies the express authorization of the information holder for the processing of personal data by Fundación WWB Colombia.

Whoever presents, registers or records the work proposal for the research project as a natural person or the legal person in whose name the project is presented, declares that he or she has received express authorization from all natural and legal persons linked to this project, to provide the information referred to in the data management law, undertaking to respond to Fundación WWB Colombia, for any lawsuit, present or possible litigation, judicial or extrajudicial claim, formulated by any of the natural or legal persons linked to the project.

#### **17. INTELLECTUAL PROPERTY RIGHTS**

The data collected during the fieldwork period, the property rights over the results of the funded research project and the moral rights over the results of the research are the property of the beneficiary.

#### **18. PUBLICATION OF RESULTS**

Beneficiary individuals/groups will submit to WWB Colombia, during the closing period and as a requirement for completion, a publishable article<sup>24</sup>, derived from the funded fieldwork, to be disseminated on the WWB website. To do so, beneficiary individuals/groups will select an aspect of the project results that relates to the following thematic areas: entrepreneurship, women's empowerment, financial inclusion, participatory and collaborative research, ruralities, and leadership, or with the thematic area of the research field in which the project is inscribed<sup>25.</sup>

Similarly, according to the research findings, the recommendations form should be submitted to the Foundation<sup>26</sup> during the closing period. In addition, at least one workshop must be held with the Foundation's collaborating personnel to discuss the results.
